

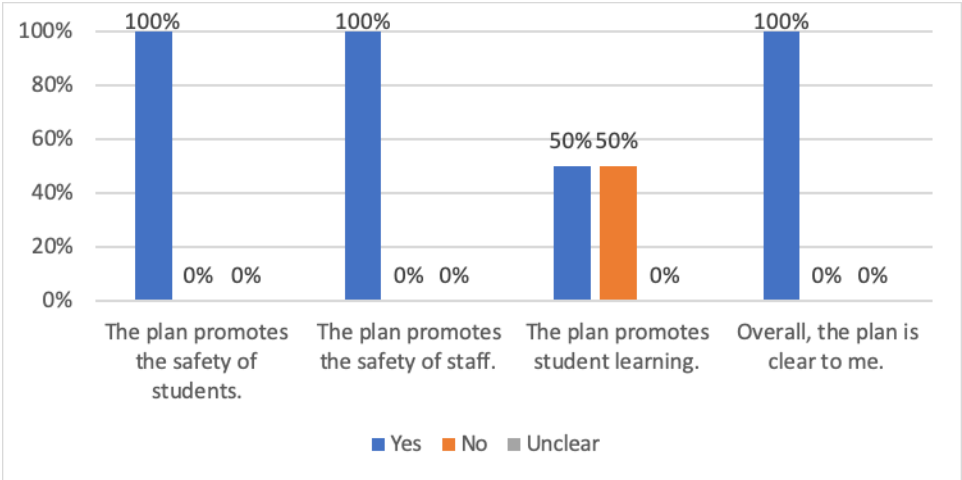
School Reopening Feedback – Round 1

Burlingame Creek School

There were 10 respondents who provided feedback about Burlingame Creek School in the online survey form. Eight were staff members, and two were parents or guardians of a student.

Both parents/guardians agreed that the plan promotes safety of students and staff and was clear overall. The majority of staff members agreed that the plan promotes student learning.

Percentage of Parents/Guardians Agreeing with Each Statement



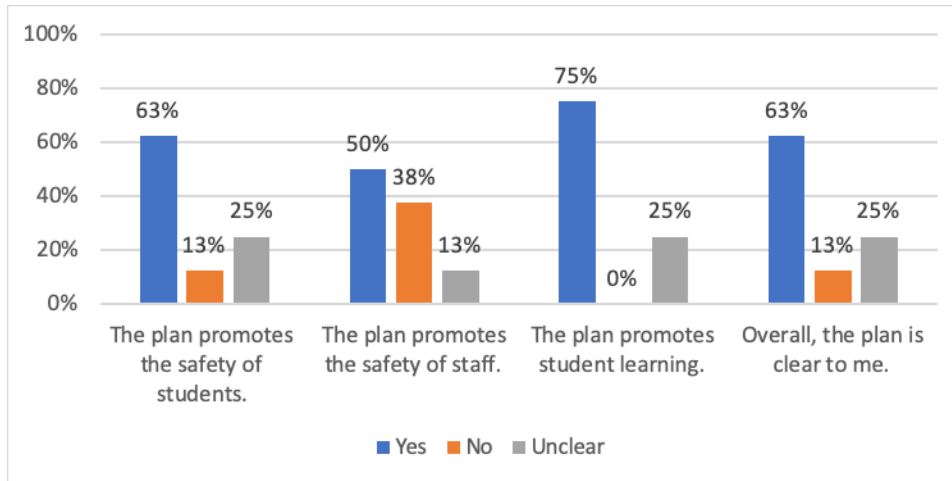
For the statement “The plan promotes the safety of students,” 100 percent of parents/guardians said yes.

For the statement “The plan promotes the safety of staff,” 100 percent of parents/guardians said yes.

For the statement “The plan promotes student learning,” 50 percent of parents/guardians said yes and 50 percent said no.

For the statement “Overall, the plan is clear to me,” 100 percent of parents/guardians said yes.

For the statement “The plan promotes the safety of students,” 63 percent of staff members said yes, 13 percent said no, and 25 percent said unclear.

For the statement “The plan promotes the safety of staff,” 50 percent of staff members said yes, 38 percent said no, and 13 percent said unclear.

For the statement “The plan promotes student learning,” 75 percent of staff members said yes, and 25 percent said unclear.

For the statement “Overall, the plan is clear to me,” 63 percent of staff members said yes, 13 percent said no, and 25 percent said unclear.

I still have questions about:

- What does it mean to screen for symptoms? Are we going to have temp checks for students and staff each morning?
- This is not a plan. It is an FAQ sheet..
- My major concern is that we won't be able to continue to offer support safely, Those of us over the age of 50 have the very real feeling that it is either the job or our health. I agree with all the plan as it is laid out and appreciate the care taken its just that with casses spiking the idea of even a small opening in the fall feels untenable.

I am concerned about:

A parent/guardian said:

- What about he ability of meeting my child's IEP with only two days in class? He cannot do distance learning as it is extremely overwhelming for him as he was not able to do it during the shutdown after spring break to the end of the school year. He was getting A grades before the shut down and they only

gave him a "P" on his final. I suspect it was because of his inability to do distance learning and they did not want to fail him.

Staff members said:

- I am concerned about morning and pm screening. I hope we have temperature checks for staff and students.
- My concern is about if someone is exposed to the virus / Actually got it and mesd nurses have to evaluate the issue what is the timeline on that? The entire school now infected and we are at risk what is the plan?
- Safety in general, staff safety... what happens when an employee falls ill? Is their leave paid until they are well? Or until it runs out? Our students may not abide by social distancing, what would be the result? Suspension? Change of placement to distance learning? Are staff expected to clean the building in addition to their assigned duties? In regards to employees who cannot risk exposing themselves, will they be paid? I'm worried about prevention and the district's due diligence in taking care of their employees just as much as their students.
- Not having enough PPE for staff and students.
- I am Concerned about returning to in person learning. The cases are still climbing, testing is still not efficient and there is no vaccine yet.

- My child will benefit for in school not distant learning.

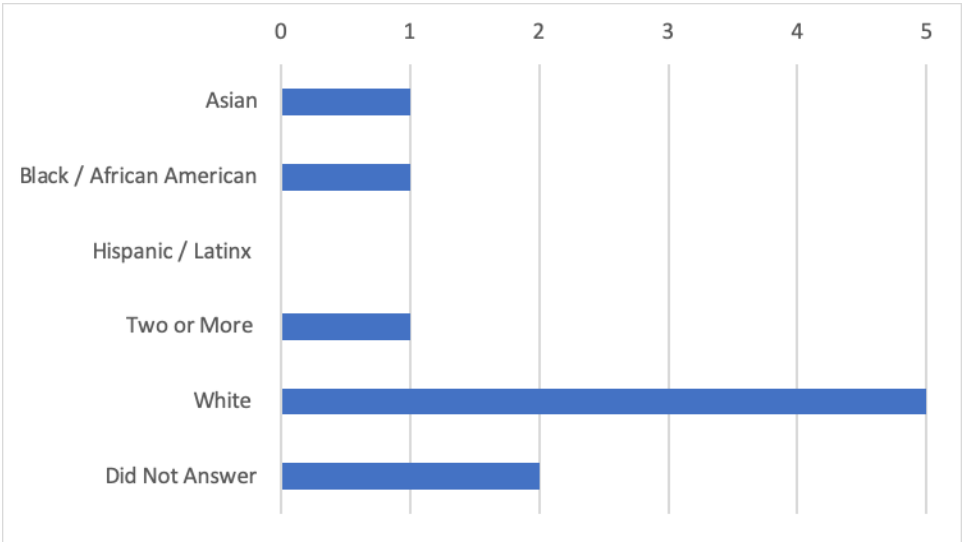
Staff members said:

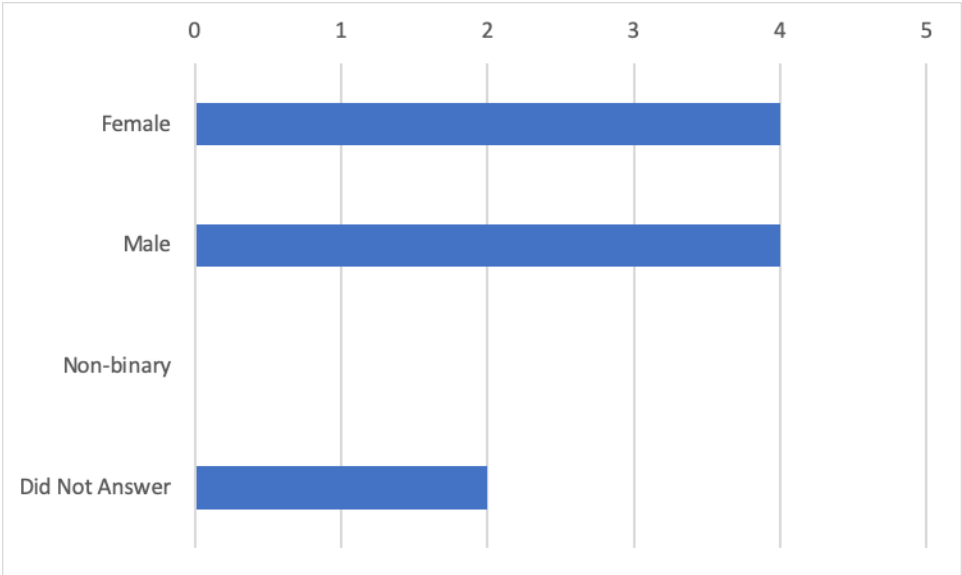
Three staff members requested follow-up contact.
